

# Singularity True Open Game License (STOGL) v2

## 1. Grant.

1.1 In return for your agreement to be bound by the terms and conditions of this Singularity True Open Game License ("License"), and subject to those terms and conditions, the Sons of the Singularity hereby grants you a worldwide, royalty-free, perpetual, non-exclusive license to use, distribute (commercially or otherwise), and make derivative works of the Licensed Material within Identified Products (see section #9). The License shall be irrevocable unless you breach any of the terms or conditions of this License.

1.2 "Licensed Material" within Identified Products shall mean the campaign setting, artifacts, creatures, characters, stories, storylines, plots, thematic elements, concepts, themes, spells, enchantments, personalities, special abilities, backgrounds, places, locations, environments, creatures, equipment, and magical or technological abilities or effects. "Licensed Material" DOES NOT include original art work or graphical design elements displayed or set out in Identified Products.

1.3 The United States Copyright Act (17 U.S.C. §102) expressly provides that "in no case does copyright protection for an original work of authorship extend to any idea, procedure, process, system, method of operation, concept, principle, or discover, regardless of the form in which it is described, explained, illustrated, or embodied in such work."
